MARCH 1971, located and claimed, and by these presents do ES locate and claim, by right of discovery and location, in compliance with the Mining Act of Congress,

approved May 10, 1872, and all subsequent Acts, and with local customs, laws and regulations, CLAIM'S

1,500 BY 1,800 linear feet and horizontal measurement on the SILVER & ALL ASSOCIATED ORE'S & TUNGSTEN COBALT NICKEL ETC, ETC, TITANIUM ETC lode, vein, ledge or deposit along the vein thereof, with all its dips,

angles and variations, as allowed by law, together with 900 feet ON EACH

side and 1,500 feet on the NORTH TO SOUTH side of the middle of said vein at the surface, so far as can be determined from present developments; and all veins,

lodes, ledges or deposits and surface ground, within the lines of said claim is 1500 feet

running DUE NORTH from center of discovery CENTERLINE and 900 feet running DUE EAST & 900 DUE WEST from center of discovery SILVER TUNGSTEN ANTIMONY; said discovery

BEGINNING at Cor. No. 1 (the S.W. SOUTHWEST corner), running thence 1500 feet DUE NORTH, to a post marked N.W. COR.; thence 900 FT feet DUE EAST, to a post marked CENTERLINE corner (Cor. No. 2); thence 900 FT feet DUE EAST, to a post marked N.E. corner (Cor. No. 3); thence 1500 feet DUE SOUTH, to a post marked S.E. SOUTHEAST COR; thence 900 feet DUE WEST, to a post marked CENTERLINE corner (Cor. No. 4); thence 900 feet DUE WEST to a post marked SOUTH WEST corner, the place beginning.

This claim is further described as follows: The point of discovery upon which this notice is posted is in a EASTERLY direction from the center of the SUNSET FALLS line, distant 900 feet. From Cor. No. 4 CENTERLINE AND bears 900 FT NORTH distant FROM RIVER and TO SECOND ORE OUTCROP ON CENTER LINE. 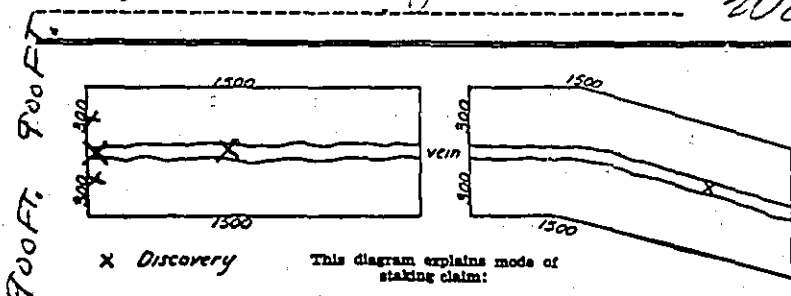
