

Porter to Hood Land Co.

The Grantors Johnston P. Porter and Janie L. Porter his wife, both of the county of Multnomah, and state of Oregon, for and in consideration of One dollar (\$1.00) and other good and valuable considerations in hand paid, convey and warrant to Hood Land Company a corporation organized under the Laws of the State of Oregon, all their interest in the following described real estate: The southeast quarter ($\frac{1}{4}$) of the northwest quarter ($\frac{1}{4}$) the northeast quarter of the southwest quarter, the west one half of the southwest quarter, the southeast quarter of the southwest quarter and the southwest quarter of the southeast quarter of Section four (4); Lot two (2), the south one half of the Northeast quarter, lot three (3), the southeast quarter of the Northwest quarter, the northeast quarter of the southwest quarter and the Southeast quarter of Section six (6); the southeast quarter of the northwest quarter, the south one half of the Northeast quarter and the northeast quarter of the southeast quarter of Section eight (8); the North one half of the northwest quarter of the northeast quarter, the northeast quarter of the northwest quarter, the southeast quarter of the northwest quarter, the southwest quarter of the northeast quarter, the south one half of the northwest quarter of the northeast quarter, the west one half of the northwest quarter, the west one half of the southwest quarter, the east one half of the southwest quarter and the east one half of the northeast quarter of section nine (9); the west one half of the northwest quarter and the west one half of the southwest quarter of the Northwest quarter of Southeast quarter and North half of Southwest quarter of SE $\frac{1}{4}$ of Sec. 16, section ten (10), the Northeast quarter of Section seventeen (17), and Lot one (1) in section five, with the exception of five (5) acres more or less in the southeast corner of said Lot one (1) beginning at the said southeast corner of said lot one (1), thence running westerly along south line of said lot one (1) five hundred twenty-one (521) feet; thence northerly and parallel with the east line of said lot one (1) four hundred seventeen (417) feet; thence easterly and parallel with said said south line of said lot one (1) five hundred twenty one (521) feet; thence southerly along east line of lot one (1) to place of beginning; all of the above described property being in township three (3) North of Range ten (10) East of Willamette Meridian in the County of Skamania, State of Washington.
