SCALES TO OLSON

THIS INDENTURE, Made this 19th day of April in the year of our Lord one thousand nine hundred and thirteen, Between R.D.Scales and Jottie Scales, his wife, parties of the first part, and Segrid Olson, party of the second part:

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Eleven hundred and no/100 (\$1100.00) Dollars, lawful money of the United States, to them in hand paid, by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to her heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to-wit:

All of lots seventeen and eighteen, and all of lot nineteen excepting a strip six and one half feet in width off the north side thereof, in Block six of the Town of Stevenson, according to the official plat thereof on file and of record in the office of the County Auditor of Skamania County, Washington. together with all and singular the tenements hereditaments and appurtenances thereunto belonging.

THIS CONVEYANCE, is intended as a mortgage to secure the payment of Eleven hundred and no/100 (\$1100.00) Dollars, lawful money of the United States, together with interest thereon at the rate of eight per cent, per annum from date until paid, according to the terms and conditions of one certain promissory note, bearing date April 19th, 1913, made by R.D.Scales and Jottie Scales payable on or before three years after
