WILLSON TO BANK OF STEVENSON.

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Four Hundred Fifty (\$450.00) Dollars, lawful money of the United States, to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to their heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania, and State of Washington and particularly bounded and described as follows, to-wit:
