Know all men by these presents that I, Frank M. Seeley of Skamania County State of Washington in consideration of the sum of Ten (\$10.00) Dollars in hand paid by John F. Reid, does hereby sell and convey unto the said John F. Reid, his successors and assigns the following described premises situated in the County of Skamania, State of Washington to-wit:

All of Lot eight (8) in Seeley's Subdivision of the southwest quarter of Section nineteen in Township three (3) North of Range ten (10) East of Willamette meridian. Also a right to lay and maintain a water pipe across any of the land owned by said Frank M. Seeley, said pipe to be placed deep enough in the ground so that it will not interfere with cultivation. Also the right to build and maintain an irrigation flume along the boundary lines of any of the lots laying above the lot described herein. Also the right of way for a road to a strip of land 10 feet in width extending from the southeast corner of Lot No. 8 along the line between Lots No. 9 and No. 10 (said line being the center of said 10 foot strip) to a point where the county Road crosses said line.
