



NOTICE IS HEREBY GIVEN That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1,500 linear feet in length, and 600 feet in width on the Silver Queen

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery Shaft (cut or tunnel), from thence

200 feet in a Westerly

direction to an end post marked No. 2, thence 300 feet in a Northerly

direction to a corner post marked No. 3, thence 1,500 feet in a Easterly

direction to a corner post marked No. 4, thence 600 feet in a Southerly

direction to a corner post marked No. 5, thence 1,500 feet in a Westerly

direction to a corner post marked No. 6, thence 300 feet in a Northerly

direction to said end post No. 2; hereby locating and intending to claim 200

feet in a Westerly direction from discovery to the West

end line, and 1,500 feet in the opposite direction from discovery to the

East end line, and 300 feet on each side of the middle of said lode or ledge, for the purpose of mining the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. This claim is further de-

scribed as follows: This is the Silver Queen Claim No. 1. The discovery post is 20 feet east of the Trout Lake - Randle road or road N. 84, and the discovery post is 0.6 mile south of the Lewis River bridge on said road, also in section 19, T9N. R10E.
