Mining District, County of Skamania, of Washington

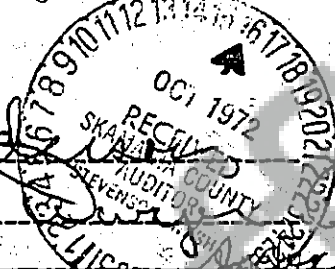

INDEPENDENCE Lode No. 9, Beginning at the NW corner of the location whence U.S. Location Monument No. 5 bears N 46 deg 54 min E 2071.1 feet distant and running thence S 33 deg 42 min W 600 feet, thence S 56 deg 18 min E 1500 feet, thence N 33 deg 42 min E 600 feet and thence N 56 deg 18 min W 1500 feet to the place of beginning.
