The Section three, containing six hundred sighty-one and sighty-four-hundredths acres; the Section seven, containing six hundred twenty-nine and twenty-eight-hundredths acres; the Section nine, containing six hundred twenty-nine and twenty-eight-hundredths acres; the Section nine, containing six hundred forty acres; the west half of Section eleven, containing three hundred twenty acres; the Section fifteen, containing six hundred forty acres; the Section seventeen, containing six hundred forty acres; the Section nineteen, containing six hundred twenty-nine and ninety-six-hundredths acres; the Section twenty-one, containing six hundred forty acres; the west half of Section twenty-three, containing three hundred twenty-acres; the Section twenty-seven, containing six hundred forty acres; the Section twenty-seven, containing six hundred forty acres; the Section thirty-one, containing five hundred thirty-three and ten-hundredths acres; the Section thirty-three, containing five hundred seventy-five and thirty-hundredths acres; and the Section thirty-five, containing five hundred ninety-one and fifty-five-hundredths acres; ---and containing, in the aggregate, twenty thousand twenty-eight and thirty-two hundredths acres:

NOW KNOW YE, That the UNITED STATES OF AMERICA, IN consideration of the premises, and pursuant to the said Acts of Congress, HAVE GIVEN AND GRANTED, and by these presents DO GIVE AND GRANT, unto the said NORTHERN PACIFIC RAILWAY COMPANY, successor in interest to the Northern Pacific Railroad Company, its successors and assigns, the tracts of land listed as aforesaid and embraced in the foregoing; TO HAVE AND TO HOLD the said tracts with the appurtenances thereof, unto the said NORTHERN PACIFIC RAILWAY COMPANY, successor as aforesaid, and to its successors and assigns, forever.

IN TESTIMONY WHEREOF, I, Theodore Roosevelt, President of the United States of America, have caused these letters to be made Patent, and the seal of the General Land Office to be hereunto affixed. GIVEN under my hand, at the City of Washington, the second day of March, in the year of our Lord one thousand nine hundred and eight, and of the Independence of the United States the one hundred and thirty-second.
