That said work and improvements were done and performed by and/or at the expense of said Duval Corporation and complies with the laws of the United States of America pertaining to assessment work or annual labor for the year ending September 1, 1973, and that said work as performed was for the benefit of said mining claims as a group and for the purpose of exploration and possible development of said mining claims.

That the following is a description of work done, to-wit:

A total of 3,910 feet of drilling was completed in 9 holes. In addition, some geophysical survey and geo-chemical sampling was done and evaluation of these surveys was made. The drilling work is still in progress.
