It is hereby mutually understood and agreed that the grantee, his heirs and assigns forever, will never bore or prospect for hot water or mineral waters, nor permit the same to be done by any other person or persons, upon the strips of land herein conveyed, which said strips of land are conveyed for county road purposes.

Sealed with our seals and dated the 29th day of February one thousand nine hundred and eight.

The condition of the above obligation is such, that if the above bounden P.S.C.Wills shall on or before the 28th day of February one thousand nine hundred and eleven made execute and deliver unto the said Mae Ormsby Gray (provided that the said Mae Ormsby Gray shall, on or before that day, have paid to the said P.S.C.Wills the sum of Four Hundred and Twenty-nine (\$429.00) Dollars (of which the sum of \$75.00 is paid the receipt of which is hereby acknowledged) Balance to be paid at \$10.00 per month with 6% interest per annum, Provided that if Mae Ormsby Gray will begin improvements on said property within 60 days from date hereof, no interest will be charged and 10% of all back payments will be granted
