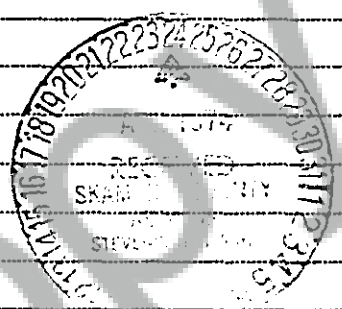
This diagram explains method of description of claim.

NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and does hereby locate 1500 linear feet in length, and 600 feet in width on the SUNSET

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery Shaft (cut or tunnel), from thence

50 feet in a EASTERLY
direction to an end post marked No. 2, thence 300 feet in a NORTHERLY
direction to a corner post marked No. 3, thence 1500 feet in a WESTERLY
direction to a corner post marked No. 4, thence 600 feet in a SOUTHERLY
direction to a corner post marked No. 5, thence 1500 feet in a EASTERLY
direction to a corner post marked No. 6, thence 300 feet in a NORTHERLY
direction to said end post No. 2; hereby locating and intending to claim 50
feet in a EASTERLY direction from discovery to the EAST
end line, and 1450 feet in the opposite direction from discovery to the WEST
