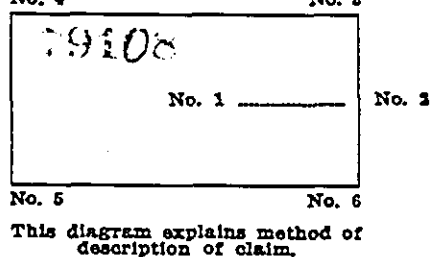

Notice of Mining Location

NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length,
and 600 feet in width on the Lode

79108 lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery Shaft (cut or tunnel), from thence
150 feet in a western
direction to an end post marked No. 2, thence 300 feet in a southern
direction to a corner post marked No. 3, thence 1500 feet in a Eastern
direction to a corner post marked No. 4, thence 600 feet in a Northern
direction to a corner post marked No. 5, thence 1500 feet in a Western
direction to a corner post marked No. 6, thence 300 feet in a Southern
direction to said end post No. 2; hereby locating and intending to claim 150
feet in a Western direction from discovery to the West
end line, and 1350 feet in the opposite direction from discovery to the

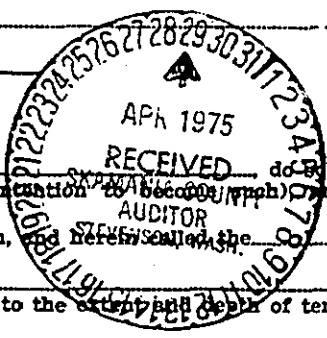
