Reed and unto his heirs and assigns forever, all of my right, title and interest and claim in and to an undivided half ($\frac{1}{2}$) of all that certain tract of real estate, situate in the County of Skamania and State of Washington, to-wit: The South half of the Northwest quarter, the Northeast quarter of the Northwest quarter and the Southwest quarter of the Northeast quarter of Section twenty-seven (27) in Township two (2) North, of Range six (6) East of Willamette Meridian, containing one hundred and sixty (160) acres. To Have and to Hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, to the said N.
