Whereas the Santa Fe Pacific Railroad nompany being the owner of a tract of land described as follows: The North half of the Southeast quarter of Section thisty three in Township twenty twenty-one North of Range eight East of Gila and Salt River Meridian in Arizona, containing eighty acres situated and included within the limits of a public forest reservation known and officially descignated as the San Francisco Mountain Forest Reserve in Arizona, has under he provisions of the act apported June 4th 1897, entitled an act making appropriations for a sundry civil expenses of the Government for the fiscal year ending June thertieth 1898 and for other purposes, reconsted and relinquished the said fact to the united States and has under the provisions of said act selected in lieu thereof the following described tract of vacant pubclis land now open for settlement to-wit?
