This Indenture witnesseth that Bernhard Erikson and Paulina Erikson man and wife,for and in consideration of the sum of four hundred eighty seven and 50/100 dollars to them in hand paid have barained and sold and by these presents do grante,bargain,sell and convey unto Nic Gregorius and Mary A.Gregorius man and wife the following described premises to-wit: Beginning at a point six hundred ninety (690) feet East of the Southwest corner of the Northwest quarter of the Southwest quarter of Section 21 Township 3 North of Range 8 East of W.M.,running thence North three hundred thirty six feet nine inches;running thence East to the quarter section or boundary line,running thence South three hundred and thirty six feet and nine inches,running thence west to the place of beginning,containing four and seven eights acres more or less.The grantors herein also include in this instrument a right of way of a strip of land 15 ft wide by 690 ft long commencing at the southwest corner of the NW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sec.21 Tp.3 N.R.8 E.W.M.,extending to the land herein sold to the grantees;
