SEELEY TO DETWILLER

THIS AGREEMENT made this 16th day of September, A.D. 1913, by and between H.M. French as guardian of Frank M. Seeley, insane of Benton County, Washington, and W.G. Detwiller and Greta Beach Detwiller, his wife, parties of the second part,

WITNESSETH; That whereas the party of the first part, the duly appointed guardian of Frank M. Seeley, insane by the County Court of Benton County, Washington is the owner and holder of a certain promissory note for \$825.00 made by W.F. Cash and Lettie B. Cash (husband and wife), dated August 25th, 1909 payable to the order of said Frank M. Seeley and which note is secured by a mortgage on real property in the County of Skamania, State of Washington, recorded in the office of the County Auditor of said County and State in Book I of Mortgages at page 62 on September 11th, 1909, and which said real property was sold and conveyed by said W.F. Cash and wife to the second parties herein.

AND WHEREAS in consideration of the sum of One Dollar to him in hand paid, said party of the first part has extended and does hereby extend the time of payment of the said note and mortgage from August 25, 1913 to August 25th, 1917.

NOW THEREFORE, In consideration of said extension, said parties of the second part do hereby agree with the said party of the first part to pay the interest on said note from August 25th, 1913 until said sum of \$825.00, the principal of said note shall be fully paid, at the rate of eight (8) per cent per annum, payable semiannually on the 25th day of February and the 25th day of August of each year. Said interest being evidenced by eight (8) additional interest coupon notes of even date herewith.

And the second parties further agree to pay the said principal due on said note, and the said additional interest coupon notes in gold coin of the United States of the present legal standard weight and fineness, at their maturity.

It is hereby further agreed that all the stipulations and provisions of said principal note and all the stipulations, provisions and covenants of the mortgage given to secure the same, including power of sale therein contained, shall remain in full force and effect, so far as they can be applied thereto.
