WITNESSETH, That said mortgagors, in consideration of Five Hundred (\$500.00) Dollars, to them paid by said mortgagee, do hereby grant, bargain, sell and convey unto said mortgagee, her heirs, executors, administrators and assigns, that certain real property situated in Skamania County, State of Washington, bounded and described as follows, to wit: The West Half of the Southeast quarter of Section Nine (9) in Township One (1), North of Range Five (5), East of the Willamette Meridian, containing Eighty (80) acres of land, as described in Homestead Certificate No. 3139, and situate in said County of Skamania, State of Washington, also
