The South half of the Southwest quarter of section three in Township two North of Range seven East of Willamette meridian, containing eighty acres more or less. Together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining and also all his estate right title and interest in and to the same including dower and claim of dower. To have and to hold the above described and granted premises unto the said Frederick A. Kribs his heirs and assigns forever. And Oscar W. Nilsson the grantor above named does covenant to and with Frederick A. Kribs his heirs and assigns that the above granted premises are free from all incumbrances except taxes for year 1909 and that he will and his heirs executors and administrators shall warrant and defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever.
