ATTWELL TO ASH.

THIS INDENTURE WITNESSETH, That John W. Attwell, a single man, of Stevenson, Washington, formerly co-partner with E.P. Ash in the firm of Ash and Attwell, co-partners, party of the first part, for and in consideration of the sum of one dollar to him in hand paid by E.P. Ash, of Stevenson, Washington, party of the second part, has Granted, Bargained, and Sold, and by these presents does Grant, Bargain, Sell and Convey unto the said party of the second part and to his heirs and assigns, his undivided one half interest in and to the following described real property situate, lying and being in the county of Skamania state of Washington, to-wit:

Lots ten (10) eleven (11), twelve (12), fifteen (15) and Sixteen (16) in Block six (6), and Lots seven (7), eight (8) thirteen (13), fourteen (14), fifteen (15) and sixteen (16) in Block Nine (9) of the Town of Stevenson according to the official plat thereof on file in the office of the county Auditor of Skamania County, Washington.

Also the following: Beginning at a point 890.5 feet south of the center of Section 36, Township 3 North of Range 7 East of Willamette Meridian, thence south 580 feet, thence south 84 deg. 22' west 1.5 feet, thence north 57 deg. 59' west 202.1 feet, thence north 58 deg. 24' west 118.1 feet, thence north 11 deg. 19' west to a point 990 feet south of the north line of the said Southwest quarter of Section 36, thence north 99.5 feet, thence east to the place of beginning.
