MICHELL TO MASON

KNOW ALL MEN BY THESE PRESENTS: That I, P.E. Michell mortgagee, named in a certain deed of conveyance, wherein Frank Morrison was named as Grantor, and C.R. Mason was named as Grantee, now of record in Book N of Deeds pages 309 and 310 thereof of the records of deeds of Skamania County Washington, wherein and whereby the said grantee therein, C.R. Mason assumed a mortgage of \$175. and interest running to P.E. Michell grantor herein, under date of said deed of September 23rd, 1911, wherein the grantor Frank Morrison conveyed to said C.R. Mason, grantee the following described real estate situated in Skamania County, Washington, viz: The west one half ($\frac{1}{2}$) of that certain tract of land deeded to Frank B. Morrison on December the 27th 1910, by John Mitchell and E. Mitchell his wife the land thereby granted being all that part of said tract laying and being west of a line drawn south from the center of the north line of said tract, by said Mitchell and wife which said tract is described as follows; all that part of the Felix G. Iman Donation Land claim, situated in the North-east quarter ($\frac{1}{4}$) of the north-east quarter ($\frac{1}{4}$) of section Two (2) township two (2) north of range seven (7) east of the Willamette Meridian, except that portion heretofore transferred by grantors herein to J.
