Lot twenty-two (22) in Block three (3) in the Town of Stevenson, as shown by the plat thereof now on file and of record in the office of the Recorder of Conveyances in and for said county of Skamania. To have and to hold the said premises with all their appurtenances unto the said party of the second part and to her heirs and assigns forever; and the said Chas J. Stubling and Anna Stubling his wife, parties of the first part, for themselves and for their heirs executors and administrators do hereby covenant to and with the said party of the second part, her heirs and assigns that they are the owners in fee simple of said premises, and that they are free from all incumbrances whatsoever and that they will warrant and defend the title thereto against all lawful claims whatsoever.
