Holtgreive his wife, of the County of Clarke state of Washington, and J.V.Gheen, of the County of Clakamas State of Oregon in consideration of the sum of ten (\$10.00) dollars to them paid by Sam Samson of the County of Skamania State of Washington, have bargained and sold and by these presents do grant, bargain sell and convey unto the said Sam Samson his heirs and assigns all the following bounded and described real property situated in the County of Skamania State of Washington to-wit: Beginning at a point in the Township line 15 chains 75 links east of the quarter section corner in the south boundary line of section 36 Township three North of Range seven East of Willamette meridian, running thence north 67 deg. 38' east 430 ft; thence north 63 deg. 38' east 230 ft; thence north 26 deg. 22' west 1160 feet; thence west 35 feet; thence south 1295.6 feet to the place of beginning, containing 9 acres and 59/100 acres, excepting therefrom about one (1) acre in the southwest corner of said tract heretofore conveyed by Henry Holtgreive and wife to School District No. three in said County and State.
