ADAMS TO AMEN.

THIS INDENTURE, Made this 28th day of February in the year of our Lord one thousand nine
 hundred and Fourteen, Between J.A.Adams, a single man, party of the first part, and F.M.
 Amen of Carson, Wash. party of the second part:

Witnesseth, That the said party of the first part, for and in consideration of the sum
 of One Hundred Dollars lawful money of the United States, to him in hand paid by the said
 party of the second part, the receipt whereof is hereby acknowledged, does by these presents
 Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to
 his heirs and assigns, the following described tract or parcel of land, lying and being in
 the County of Skamania and State of Washington, and particularly bounded and described as
 follows, to-wit: The Southeast Quarter of the South West Quarter of Section Eighteen and
 the East Half of the Northwest quarter and the Northwest quarter of the Northeast quarter of
 Section nineteen, in Township Three, North of Range Eight East of the Willamette Meridian,
 Washington, containing One Hundred Sixty acres. together with all and singular the tenements
 hereditaments and appurtenances thereunto belonging.
