Venden, Skamania County, State of Washington the party of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, assign, transfer and set over unto the said party of the second part a certain Indenture of Mortgage bearing date the 2nd day of February A.D.1912, made and executed by Watt A. Hall and Missouri T. Hall, (husband and wife) Margaret E. Jensen, Mortgagors to Joseph O.
