

## Sholin to Gilman

This Indenture Made on this the 28th day of April 1910 by and between Jonas Sholins and Sophia Sholin his wife of Portland, Oregon hereinafter called the grantors, and D.E. Gilman, of Heppner Oregon hereinafter called the grantee, Witnesseth, that the said grantors for and in consideration of the lawful sum of sixteen hundred (\$1600.00) dollars, received of said grantee, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell and convey unto said grantee and unto said D.E. Gilman his heirs and assigns, that certain real property with the appurtenances hereditaments and privileges situated in the County of Skamania State of Washington and fully described as follows to-wit:

The Northeast quarter of the Northeast quarter, or lot numbered one (1) of Section one (1) in Township three (3) North of Range seven and one half (7½) East of Willamette Meridian in Skamania County Washington, containing forty acres. To have and to hold the above described and granted premises unto the said grantee his heirs and assigns forever.

And the said grantors their heirs and personal representatives do hereby covenant with the said grantee his heirs and assigns that we are seized in fee simple of above granted premises that said premises are free from all liens or incumbrances and that we will warrant and defend the same against all lawful claims and demands of all persons whomsoever.

Young to Gilman

The grantor, J.B. Young, a single man, for and in consideration of One dollar and other valuable considerations in hand paid, convey and warrant to D.E. Gilman the following describe real estate situated in the County of Skamania State of Washington to-wit:
