Hyde & Co. its successors and assigns forever all of our right title and interest and also all the right title and interest that way may hereafter acquire of, in and to those certain tract of lands situated in the County of Skamania State of Washington to-wit: The Southeast quarter of the Northeast quarter of Section fourteen (14), in Township seven (7) North of Range six (6) East, the North half, the north half of the Southwest quarter and the North half of the southeast quarter of section twenty-two (22); the Northwest quarter of the northwest quarter, the south half of the northwest quarter, the north half of the southwest quarter, the west half of the northeast quarter, the southeast quarter of the Northeast quarter and the southeast quarter of Section twenty-three (23), the south half of the northwest quarter, the southwest quarter and the west half of the southeast quarter of section twenty four (24), all of Section twenty-five (25); the east half of Section twenty-six (26), the east of the northeast quarter and the east half of the southeast quarter of Section thirty five (35), in Township eight (8) of Range six (6) east of Willanette Meridian, and containing twenty four hundred and forty (2440) acres more or less To have and to hold the said land and every part and parcel thereof, together with all the appurtenances thereunto belonging unto the said F.A.
