Know all men by these presents that Ruben E. Collins a single man of the city of St. Johns State of Oregon of lawful age, in consideration of \$1.00 and other valuable considerations to him paid by Renville Chinook of the city of Portland of Multnomah County State of Oregon do hereby remise release and forever quitclaim unto the said Renville Chinook and unto his heirs and assigns all my right title and interest in and to all that parcel of real estate situate in Skamania County State of Washington to-wit:

Beginning at the Northeast corner of the South half of the Northeast quarter of section 18 Township 3 North of Range 8 East of Willamette meridian, from thence west along the north line of the south half of the Northeast quarter of said section 18, 160 rods, more or less to line running north and south through center of said section 18 and dividing the east half from the west half thereof; thence South along said last mentioned line 60 rods thence east on line parallel with said north line of said south half of said Northeast quarter section and sixty rods distant therefrom 160 rods more or less to section line, being North and south between section 18 and section 17 of said township and range and from thence North along said last named section line 60 rods to place of beginning, containing sixty acres more or less, all in Skamania County State of Washington.
