KNOW ALL MEN BY THESE PRESENTS that we, Hiram W. Sibley and Margaret D. Sibley, husband and wife, of the City of Rochester, County of Monroe and State of New York, for and in consideration of the sum of Ten Thousand (\$10,000.00) Dollars, to us in hand paid by J. E. Blazier of Portland, Oregon, the receipt whereof we do hereby acknowledge, have granted, bargained and sold, and by these presents grant, bargain, sell, convey and confirm unto the said J. E. Blazier, and to his heirs and assigns forever, all that certain tract of land lying and being in the County of Skamania and State of Washington, and particularly described as follows, to-wit:

The Southeast quarter of the Southeast quarter of Section Seven (7), the East half of Section Eighteen (18), and the North half of the North half of Section Nineteen (19); all in Township Two (2) North of Range Six (6) east of Willamette Meridian, containing Five Hundred and twenty acres, more or less; together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining, and all of our right, title, interest, claim, possession or demand of any kind whatever, whether at law or equity, of, in or to the above described premises, and each and every part and parcel thereof.

TO HAVE AND TO HOLD THE SAME unto the said J. E. Blazier and to his heirs and assigns forever, and we do hereby covenant with the said grantee, his heirs and assigns, that at the date hereof we are well seized in fee simple of the premises above conveyed, and we will, and our heirs, executors and administrators shall warrant and defend the title thereto against the lawful claims or demands of any person or persons whomsoever; except all taxes and assessments for the year 1909 and thereafter; also excepting any liens or incumbrances created by said Blazier.
