WHITNEY COMPANY TO OREGON-WASHINGTON LOGGING CO.

KNOW ALL MEN BY THESE PRESENTS, That The Whitney Company, Limited, a partnership association, organized and existing under and by virtue of the laws of the State of Michigan, in consideration of the sum of Fifty Thousand Dollars (\$50,000.) in gold coin of the United States of America, to it in hand paid by the Oregon-Washington Logging Company, a corporation organized and existing under and by virtue of the laws of the State of Oregon, does hereby grant, bargain, sell, convey and confirm unto the said Oregon-Washington Logging Company, its successors and assigns, all the following described real property, situated in the County of Skamania and State of Washington, to-wit:

The Southeast Quarter of Section Two and the Southwest Quarter of Section Thirteen in Township Two North, Range Five East; The Southwest Quarter of the Southeast Quarter, the East half of the Southwest Quarter and the Southwest Quarter of the Southwest Quarter of Section Six, Township Two North, Range Six East; The Northwest Quarter of Section Eight and the West half of Section Eighteen, Township Two North, Range Six East; The Southwest Quarter of Section Eight; Southwest Quarter of Section Seventeen; All of Section Eighteen; Southwest Quarter of Section Twenty; All of Section Twenty-eight; South Half of the South Half of Section Thirty-one and all of Section Thirty-two, Township Three North, Range Six East, Willamette Meridian:
