

## MELVIN TO WILLS

KNOW ALL MEN BY THESE PRESENTS, That we, Frank Melvin and Anna M. Melvin Husband and Wife, of Portland, Oregon, being of lawful age, in consideration of One Hundred (\$100.00) Dollars, to us paid by Peter S.C. Wills of Skamania County, Washington do hereby remise, release and forever Quitclaim unto the said Peter S.C. Wills and unto his heirs and assigns, all our rights title and interest in and to all that parcel of real estate, situate in the County of Skamania State of Washington, for the purpose of correcting the amount of acreage contained within the bounds of the Isaac H. Bush Donation Land Claim as given by the above Grantors to the Grantee by Quit Claim Deed of February 4th, 1910 and recorded in the records of Skamania County, State of Washington, February 9th, 1910, in book M, page 175, Record of deeds, of said County and State, to wit: The I.H. Bush Donation Land Claim, situated in Sections ten, eleven, fourteen and fifteen, in Township two North Range seven East of Willamette Meridian, described as follows: Starting at a point on the Columbia River in Section eleven, Township two North of Range seven East, being the Northeast corner of the Daniel F. Bradford Donation Land Claim, where the same intersects the shore line of the Columbia River, running thence north, fifty-four and one-half degrees west, fifty chains; thence south, twenty-nine degrees west, fifty-five chains to the angle corner between the Daniel F. Bradford and Isaac H. Bush Donation Land Claims to the, "place of beginning", thence north, twenty-nine degrees East, five and Ninety-hundredths chains; thence west, thirty-three and forty-hundredths chains; thence south eighty chains; thence east, fifty and thirty-hundredths chains; thence north forty chains; thence west three and ninety-five-hundredths chains; thence north, twenty-three degrees west, forty-two and fifty-hundredths chains to the angle corner of the place of beginning, containing three hundred fifty-six and eight hundredths of an acre in sections, ten, eleven, fourteen, and fifteen, Township two North of Range seven East of Willamette Meridian, being the Isaac H. Bush Donation Land Claim; also lots four, five, six and nine in Section ten, Township two North of Range seven East of the Willamette Meridian, containing ninety-one and ninety-five hundredths acres; also lot six Section fourteen and lots two and seven in Section fifteen, Township two north and range seven East of the Willamette Meridian, containing thirty-three and three-hundredths acres, making a total 481.06 acres.
