The Grants Maggie Hamilton and E.C.Hamilton her husband of Skamania County Washington, parties of the first part for and in consideration of One dollar and other valuable considerations in hand paid, convey and warrant to Olof Anderson, of Skamania County Washington, party of the second part the following described real estate situated in the County of Skamania State of Washington to-wit:

Commencing at a point thirty rods south of the northeast corner of Lot numbered six in Section thirty six Township three North of Range seven and one half west of Willamette meridian, thence west twenty six and two thirds ($26 \frac{2}{3}$) rods thence south ninety (90) rods, thence East twenty six and two thirds ($26 \frac{2}{3}$) rods, thence north ninety (90) rods to place of beginning, containing 15 acres more or less. Excepting therefrom the strip of land across the said property heretofore dedicated as a road and now a county road known as the Strawberry Road. Excepting also a strip of land 16 feet in width along the east line thereof heretofore granted to George O.Dillaboy and Wynone Dillaboy for a road. The North one half ($N\frac{1}{2}$) of the Southwest quarter ($SW\frac{1}{4}$) of the Southeast quarter ($SE\frac{1}{4}$) of the Northeast quarter ($NE\frac{1}{4}$) of Section nineteen (19) Township three (3) North of Range ten (10) East of Willamette meridian containing five (5) acres.
