This Indenture made this t ird day of August 1910 between C.S.Upright of Tacoma washington party of the first part and E Lathrop of the s me place party of the second part witnesseth that the said party of the first part for andin consideration of the sum of fifteen hundred dollars to him in hand paid by the party of the second part the receipt wheeof is hereby acknowledged does by these presents grant,bargain,sell,remise,release and forever quitclaim unto the said party of the second part and to his heirs and ass gns all the undivided one half interest in and to the fllowing described mining claims to wit: the same being locat ed and situat ed in the St.Helens Mining District in the County of Skamania State of Washington and fully descirbed as follows:

Beginning at discovery hole and running in a Northeasterly direction 300 feet thence in a Northwest erly directi on 1500 feet thence in a southwesterly direction 600 feet thence in a southeasterly direction 1500 feet thence in a no rtheasterly directi on 30, feet back to place of beginning.
