Wills to Stevenson et al

This Indenture Made this sixteenth day of August 1910 between P. S. C. Wills a single man of Stevenson Washington, party of the first part, and J. M. Steenson, George H. Stevenson and Otto Stendahl, parties of the second part Witnesseth:

That the said party of the first part for and in consideration of the sum of One dollar (\$1.00) and other valuable considerations in hand paid by the parties of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, confirm and quitclaim unto the said parties of the second part and to their heirs and assigns forever, all his right, title and interest in and to the following described real estate in Skamania County Washington to-wit:

Beginning at a point on the west line of the D. F. Bradford Donation land claim Number 37, the same being a point on the east line of the Isaac H. Bush claim No. 296, five and ninety hundredths chains (5.90) north twenty nine (29) degrees east of the quarter section corner on the west side of section eleven (11) in Township two (2) North of Range seven (7) East of Willamette Meridian, Washington, which is also an angle corner of said claims as described by the Surveyor General; thence west thirty three and forty hundredths (33.40) chains; thence south eighty chains (80); thence East fifty and thirty hundredths (50.30) chains intersecting with the west boundary of the donation claim of D. F.
