NOW, THEREFORE, if the said promissory note, principal and interest, shall be paid at maturity according to the terms thereof, this indenture shall be void, but in case default shall be made in the payment of the principal or interest as above provided, then the whole sum, both principal and interest accrued at the time default is made, shall become due and payable, and the party of the second part, its successors and assigns, are hereby empowered to foreclose this mortgage in the manner prescribed by law, And the said party of the first part and his heirs, executors and administrators does covenant and agree to pay unto the said party of the second part, its successors or assigns, the said sum of money above mentioned.
