This Indenture Witnesseth that Joseph Gregorius and Lizzie Gregorius his wife, for and in consideration of One dollar and other valuable considerations to them in hand paid, the receipt whereof is hereby acknowledged do convey and warrant to L.T. Smith, E.C. Gillett, Quincy Wade, Mrs. J.T. Smith and H.H. Olmstead and their successors as trustees, in trust for the use and benefit of the Ministry and Membership of the Methodist Episcopal Church in the United States of America, subject to the Discipline, Usage and Ministerial appointment of said Church as from time to time authorized and declared, and of sold, the proceeds shall be disposed of and used in accordance with the provisions of said discipline; the following described real estate situated in the County of Skamania State of Washington to-wit: Beginning at a point fifty rods north of the southeast corner of the Southwest quarter of the southeast quarter of Section twenty Township three North of Range eight East of Willamette Meridian, running thence west ten rods, thence south eight rods, thence east ten rods, thence north ten rods to the place of beginning, containing one half of an acre.
