Altenburg of Portland Oregon, party of the second part; Witnesseth: That the said parties of the first part for and in consideration of the sum of six hundred and fifty (\$650.00) dollars lawful money of the United States to them in hand paid the receipt whereof is hereby acknowledged do by these presents grant, bargain, sell and convey unto the said party of the second part and to his heirs and assigns the following described real property situated in the County of Skamania State of Washington and more particularly described as follows:
