executors, administrators or assigns shall be entitled to have entered in such foreclosure suit a judgment flor any deficiency remaining due upon account of the indebtedness secured hereby, including taxes, insurance or other lawful assessments after applying the proceeds of the sale of the premises above described to the payment thereof, and to the costs of such foreclosure suit.
