Know all men by these presents that we, William Sheehy and Alice Sheehy husband and wife of the city of Portland, Oregon in consideration of six hundred and forty dollars to us paid by James A. Haran of the city of Portland, Oregon, have bargained and sold and by these presents do bargain, sell and convey unto said James A. Haran his heirs and assigns all the following described real property situated in the county of Skamania state of Washington:

An undivided one fifth (1/5) interest in the North half of the northwest quarter of section eight in Township three North of Range ten East of Willamette Meridian, according to government survey thereof, together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining. To have and to hold the above described and granted premises unto the said James A. Haran, his heirs and assigns forever. And we the said grantors above named to hereby covenant to and with the said above named grantee his heirs and assigns that we are lawfully seized in fee simple of above granted premises, that the same are free from all incumbrances and that we will warrant and defend the same against all lawful claims and demands of all persons whomsoever.
