



## Notice of Mining Location

NOTICE HEREBY IS GIVEN that the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a vein or lode of mineral bearing rock in place upon the unappropriated public domain of the United States within the State of ~~Oregon~~ and said Mining District; and, in accordance with the laws of the United States, of the State of ~~Oregon~~ and the regulations of said Mining District, have located and do hereby locate a claim upon such vein or lode by posting this notice of such discovery and location on a substantial post at the point of discovery, marked Post No. 1. The name of the claim is Copper Creek #82 Claim, further described as follows: 600 feet wide by 1500 feet deep. (E-W direction).

Commencing at a post marked No. 1 (Discovery Post), from thence
