Know all men by these presents that William H Davis and Minnie Davis his wife of Hood River State of Oregon in considration of ten and no/100 dollars to them paid by Henry Metzger of Skamania county state of Washington have bargained and sold and by these presents does grant, bargain, sell and convey unto said Henry Metzger, his heirs and assigns all the following described real property lying and being in the County of skamania state of Washington to-wit: Beginning at the Northeast corner of Section twenty (20) Township three (3) North of Range eight (8) East of Willamette Meridian, running thence west thirty seven rods; thence south one hundred and fifty feet; thence East thirty seven rods, thence North one hundred and fifty feet to place of beginning, containing about two and twelve one hundredths acres (2 and 12/100) together with all and singular the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining. To have and to hold the above described premise: unto the said Henry Metzger his heirs and assigns forever. And William H.
