GILLETTE TO BANK OF STEVENSON.

THIS INDENTURE, Made this 4th day of June in the year of our Lord One Thousand nine hundred and fifteen,

BETWEEN, John P. Gillette and Louise E. Gillette, husband and wife, of Stevenson, Washington, the parties of the first part, and Bank of Stevenson, a corporation organized and existing under and by virtue of the laws of the State of Washington, the party of the second part;

WITNESSETH. That the said parties of the first part, for and in consideration of the sum of TWO THOUSAND FIVE HUNDRED DOLLARS, United States Lawful money to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents, Grant, Bargain, Sell, Convey and Confirm unto the said party of the second part, and to its assigns the following described tract, lot, or parcel of land, situate lying and being in the county of Skamania, State of Washington, and particularly bounded and described as follows, to-wit:

Beginning at a point situated 15 chains and 75 links East of the N.W. corner of the NE 1/4 of Sec. 1 Township 2 North Range 7 East W.M. Running thence south 225 feet, thence East 205.5 feet, thence south 34 deg. 30' E. 31.2 feet to corner of Courthouse Block as shown on the official plat of the town of Stevenson, thence North 55 deg. 30' East 106 feet, thence north 34 deg. 31' West 298 feet, thence south 68 deg. 47' West 152.4 feet to place of beginning, Excepting out of above description the following described tracts as follows, to wit: Beginning at a point 31.2 feet North, 34 deg. 30' West of the North East corner of Block 8 of the town of Stevenson, thence N 34 deg. 30' W. 50 feet, thence S. 55 deg. 30' W. 100 feet, thence S. 34 deg. 30' E. 50 feet, thence N 55 deg. 30' E 100 feet to place of beginning; deeded to J.M.
