

Skamania, Clarke, and Cowlitz, in the State of Washington, described according to the public surveys of the Government of the United States as follows, to-wit:

In Township three (3) North of Range Ten (10) East, Willamette Base and Meridian:

In Section 2: (a) The bed of White Salmon River, and a strip of land one hundred (100) feet in width on each bank of said river throughout said section 2.

(b) A parcel of land in Lot 2, immediately adjoining said 100 foot strip, described as beginning at a point on the West line of Lot 2, distant thereon 1150.7 feet South from the North line of the Section, running thence north on said west line 135 feet, thence N 52 deg. 30' E. 300 feet to the North line of said 100-foot strip, and thence south easterly along said north line of the 100-foot strip to the point of beginning; containing 49/100 acre.

(c) Beginning at a point near the mouth of Buck Creek S 54 deg. 45' E. 650 feet from the northwest corner of Lot 2, and 100 feet, from the line of ordinary high water in White Salmon River; running thence North 43 deg. W. 358 feet; thence N. 80 deg. 38' E. 105 feet, thence S 49 deg. 31' E. 230 feet, to point 100 feet from said highwater line; thence Southwesterly parallel to and 100 feet distant from said highwater line 130 feet to beginning; containing 67/100 acre.

(d) So much of South half of Northwest quarter as lies north and west of White Salmon River; including said 100 foot strip in said subdivision.

River (e) All of lot 306 and the northwesterly 14 rods of lot 207 of Fruit Home Colony containing 8.85 acres, lying partly in Section 2 and partly in Section 3.

In Section 3: (a) The bed of White Salmon River, and a strip of land 100 feet in width on each bank of said river throughout the section; this strip being in part also included in the separately described parcels of the Company's land.

(b) Beginning at a point S 56 deg. 30' W. 536 feet, more or less from the quarter section corner on the line between sections 2 and 3; and distant 100 feet easterly from the line of ordinary high water on the East bank of White Salmon River; thence N 29 deg. 30' E. 208 feet; thence North 0 deg. 15' E. 478 feet to a point on the dividing line between lots 306 and 305½ of Fruit Home Colony, distant 100 feet Easterly from said high water line; thence southerly parallel with said highwater line and 100 feet easterly therefrom to the point of beginning.

(c) Beginning at the S.W. corner of N½ of N.E.¼ of S.E.¼ of Section 3; thence N. 61 deg. 55' E. 385 feet; thence N. 15 deg. E. 112 feet; thence N. 25 deg. 56' W. 482.6 feet; thence N. 17 deg. 15' W. 460 feet; thence N 66 deg. 30' E 48 feet, crossing Mill Creek; thence S 31 deg. 30' E. 588 feet; thence N 86 deg. 45' E. 170 feet to point 100 feet from ordinary highwater in White Salmon River; thence southwesterly, along a line 100 feet from and parallel with said highwater line 1150 feet, to the west line of said N.E. ¼ of S.E. ¼; thence North 190 feet to beginning; containing 6.37 acres.

(d) All of the East half of the S.E.¼ of N.E.¼, lying North and West of White Salmon River.

(e) S.E.¼ of S.W.¼, and so much of West ½ of S.E. ¼ as lies west of a line 100 feet East from and parallel with the East Bank of White Salmon River.

(f) Beginning at a point on the south line of Section 3, 212.47 feet East from the quarter section corner; thence N 41 deg. 10' E. 241.65 feet; thence N 20 deg. 33' W 273.60 feet; thence N 3 deg. 44' W. 374.25 feet; thence S 88 deg. 10' W. 161.45 feet to a point 100 feet East from East Bank of White Salmon River; thence southerly parallel with said bank of the River and 100 feet easterly therefrom 612.13 feet to the south line of section 3; thence East on said line 169. feet to beginning; containing 3.85 acres.

(g) Beginning at the southeast corner of said last described tract (f); running thence
