THIS INDENTURE, Made this Eighteenth day of June A.D. Nineteen Hundred Fifteen, by and between the LA CROSSE TRUST COMPANY a corporation duly organized and existing under the laws of the State of Wisconsin, and Frank G. Tiffany, both of the city of LaCrosse LaCrosse County, Wisconsin, parties of the first part, and GODDARD AND COMPANY, INCORPORATED a corporation duly organized and existing under the laws of the State of Washington, party of the second part.
