McNutt, the parties of the first part, and Wm.E.Nagel, the party of the second part, Witnesseth That the said parties of the first part for and in consideration of the sum of one dollar lawful money of the United States to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents remise, release and forever quitclaim unto the said party of the second part and to his heirs and assigns the following described tracts lots or parcels of land situated lying and being in the county of Skamania State of Washington and described as follows, to-wit:

The Northeast quarter of the Northeast quarter of section nine (9) in Township one (1) North of Range five (5) East of W.M., containing 40 acres. Also, the following described parcel: Beginning at the Southwest corner of the Northeast quarter of said Section nine and running thence North 25 rods, thence East 30 rods, thence North 55 rods, thence East 50 rods, thence South 80 rods and thence West 80 rods to the place of beginning containing 30 rods.
