

# Notice of Mining Location

## Relocation Notice

NOTICE HEREBY IS GIVEN that the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a vein or lode of mineral bearing rock in place upon the unappropriated public domain of the United States within the State of Washington and said Mining District; and, in accordance with the laws of the United States, of the State of Washington and the regulations of said Mining District, have located and do hereby locate a claim upon such vein or lode by posting this notice of such discovery and location on a substantial post at the point of discovery, marked Post No. 1. The name of the claim is Star Creek #19 Claim, further described

as follows: 600 feet wide by 1500 feet deep.

Commencing at a post marked No. 1 (Discovery Post), from thence

from the meeting of Star Creek with Copper Creek in a southerly direction. The west end of Star Creek #19 lies against the east bank of Star Creek. There are copper sulphides and other mineral signs all over Star Creek Claims.

The general course or strike of the vein or lode as nearly as may be determined is \_\_\_\_\_

with reference to the natural object or permanent monument described above. The adjoining claims are

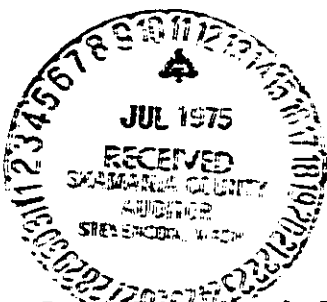
Star Creek #15 on the north side, Star Creek #17 on the west end, Star Creek #23 on the south side, and Star Creek #20 on the east end.

In construing this location notice, the singular includes the plural and vice versa, where the context so requires.
