Know all men by these presents that J. A. Holmes of Garfield, State of Utah and G. C. Griffith and Florence C. Griffith his wife of Underwood Washington, in consideration of ten thousand (10,000) dollars to them paid by the Skamania Land & Improvement Company of Underwood State of Washington, have bargained and sold and by these presents do grant, bargain, sell and convey unto said Skamania Land & Improvement company, their administrators and assigns, all the following bound and described real property situated in the County of Skamania and state of Washington:

Beginning at the Northwest corner of Section nineteen (19) Township three North of Range ten (10) East of the Willamette meridian and running thence North eighty eight degrees (88°) East two thousand six hundred ninety-two and 8/10 (2692.8) feet to the Northeast corner of the Northwest quarter of said Section nineteen (19), thence south thirteen hundred sixty (1360) feet to an iron pipe which marks the Northeast corner of the parcel of land heretofore conveyed by George S.
