half of the southwest quarter of said section ten (10).

All that part of the northeast quarter of the southwest quarter of section three (3) in township three (3) north of range ten (10) east of the Willamette Meridian, which lies within two hundred (200) feet of the thread of stream (or center line) of the White Salmon River; but subject to the right of Cora C.Lawrie and H.N.Lawrie, her husband, and their successors in interest, as an appurtenant privilege to the remainder of said legal subdivision, to cross the land above described to the waters of said White Salmon River or to the waters of such pond as may be created by damming the waters of said river.

All that part of the southeast quarter of the northwest quarter of section ten (10) in township three (3) north of range ten (10) east of the Willamette Meridian, which lies within two hundred (200) feet of the center line of the White Salmon River.

- (15) All those certain pieces or parcels of land and rights and privileges and easements in lands, situate, lying and being within the Counties of Skamania and Klickitat, State of Washington, particularly described as follows:
- (a) The northeast quarter of the northeast quarter of the northwest quarter of section ten (10) in township three (3) north of range ten (10) east of the Willamette Meridian, containing ten (10) acres, more or less.
- (b) All that part of the southeast quarter of the northeast quarter of the northwest quarter of section ten (10) and the northwest quarter of the northeast quarter of said section ten (10), in township three (3) north of range ten (10) east of the Willamette Meridian, which lies westerly of the center line of the White Salmon River and easterly of a line running two hundred (200) feet west of and parallel with the center line of said White Salmon River.
- (c) All that part of the northwest quarter of the northeast quarter and of the southeast quarter of the northeast quarter of the northwest quarter of section ten (10), in
