

northwest quarter of said section, 310 feet, more or less, to a point in the center line of the White Salmon River; thence southeasterly and following the center line of said White Salmon River (down stream) to a point in the south line of the northwest quarter of the northeast quarter of said section 10; thence east along said last named south line, 500 feet, more or less, to the point of beginning, containing 7.77 acres, more or less.

(d) A strip of land 12 feet wide to be used as a private roadway or for other purposes, running from the northeast corner of said 7.77 acre tract above mentioned, in section 10, township 3 north of range 10 east of the Willamette Meridian, along the north line of the Cameron tract easterly out to the County Road; but the ELECTRIC COMPANY shall maintain a gate at its intersection with said County Road.

(e) All that part of the southwest quarter of the northwest quarter of section two (2) in township three (3) north of range ten (10) east of the Willamette Meridian, and of the southeast quarter of the northeast quarter of section three (3) in township three (3) north of range ten (10) east of the Willamette Meridian, bounded and described as follows, to wit: Beginning at a stone monument six by ten by fourteen inches in size, set in the line dividing said sections 2 and 3 at a point north 3 degrees 1 minute west 1010 feet from the quarter section corner between said sections 2 and 3; thence running south 86 degrees and 15 minutes east, 720 feet to a point 100 feet from the right bank of the White Salmon River; thence westerly and parallel with and 100 feet from the right bank of said White Salmon River to a point south 81 degrees west, 370 feet from the beginning point of the tract now being described; thence north 81 degrees east, 370 feet to said point of beginning, containing 1.34 acres.

(f) All those portions of the south half of the northwest quarter of section two (2), and the east half of the southeast quarter of the northeast quarter of section three (3) in township three (3) north of range ten (10) east of the Willamette Meridian, which lie between the right bank of the White Salmon River and a line run across said property one hundred feet northerly of and to the right of the said right bank of the White Salmon River.

(g) All those portions of lots or tracts numbered 233, 234, 235, 236 and 241 in Fruit Home Colony, which may lie within 100 feet of the banks of the White Salmon River.

(h) All right, title and interest of the ELECTRIC COMPANY herein, whether in possession, reversion or otherwise in and to the right to use the waters and the bed of stream and a strip of land 100 feet wide on each side of the stream known as the White Salmon River where the same flows through the following described land; Lots numbered 1 and 2 of section 2, the southwest quarter of the northeast quarter, the south half of the northwest quarter and the northwest quarter of the southwest quarter of said section 2, and the southeast quarter of the northeast quarter and the northeast quarter of the southeast quarter of section 3, all in township 3 north of range 10 east of the Willamette Meridian, including the right to build dams, booms and piers in and about said river.

(i) All the right, title and interest of the ELECTRIC COMPANY, whether in possession, reversion or otherwise, in and to the right to drive and float logs, lumber and other products in the White Salmon River where the same passes through the north half of the northeast quarter and through the northwest quarter of section 10, in township 3 north of range 10 east of the Willamette Meridian, and also in and to the right to build, maintain and operate dams in said stream where the same passes through said lands.

(j) All the right, title and interest of the ELECTRIC COMPANY, whether in possession, reversion or otherwise, in and to the bed of the stream of the White Salmon River where the same passes through sections 2, 3 and 10 in township 3 north of range 10 east of the Willamette Meridian.
