(21) All that certain piece or parcel of land situate, lying and being in the Counties of Skamania and Klickitat, State of Washington, particularly described as follows:

That part of the north half of the north half of the southwest quarter of the northeast quarter of section ten (10), in township three (3) north of range ten (10) east of the Willamette Meridian, containing ten (10) acres, more or less, described as Weginning at a point on the north line of the said tract, 766.5 feet west of the northeast corner of the tract; thence south 2 degrees and 15 minutes east 333 feet, more or less, to the south line of the tract; thence west to the southwest corner of the said tract; thence north 2 degrees and 15 minutes west to the northwest corner of the tract; thence east along the north line to the place of beginning, containing four (4) acres, more or less.

(22) All that certain piece or parcel of land situate, lying and being in the County of Klickitat, State of Washington, described as follows:

Beginning at a point 889 feet north of the southwest corner of the southeast quarter of the southeast quarter of section three (3) in township three (3) north of range ten (10) east of the Willamette Meridian, and running thence north to a point within 100 feet of the White Salmon River; thence in a southerly direction along the east Sank of said river and equi-distant therefrom to a point due west of the place of beginning, and at right angles with the east side of the above described tract; thence east 1150 feet to the point of beginning. And also a certain strip of land for road purposes, towit:

Commencing at the point of beginning of the tract hereinabove first described, that is to say, beginning at a point 889 feet north of the southwest corner of the southeast quarter of the southeast quarter of section 3, in township 3 north of range 10 east of the Willamette Meridian, and running thence south 229 feet; thence west 20 feet; thence north 229 feet to the point of intersection with the east and west line of the south boundary of the above described tract, and thence east along said, boundary 20 feet to beginning.

(23) All that certain piece or parcel of land situated, lying, and being in the County of Klickitat, State of Washington, particularly described as follows;

All that part of Lot 219, Fruit Home Colony, a subdivision shown upon a duly recorded plat thereof, which lies northwesterly of a line one hundred feet from and parallel with the White Salmon River; said land being conveyed for water power and flooding purposes.

(24) All that certain piece or parcel of land situates lying and being in the County of Klickitat, State of Washington, particularly described as follows:

That part of Lots 301, 302, and 304 in Fruit Home Colony, a subdivision shown upon the duly recorded map and plat of said Fruit Home Colony, which lies northwesterly of a line one hundred feet from and parallel with the White Salmon River.

(25) All that certain piece or parcel of land situate, lying and beingin the County of Klickitat, State of Washington, particularly described as follows:

Beginning at a point on the south line of Adams' land north 89 degrees and 54 minutes east, 212.47 feet from the quarter corner between sections three (3) and ten (10), in township three (3) north of range ten (10) east of the Willamette Meridian; from said beginning point thence north 41 degrees 10 minutes east 241.65 feet to a stake; thence north 20 degrees 33 minutes west, 273.60 feet to a stake near a fence corner; thence north 3 degrees 44 minutes east 374.25 feet to a point on the south line of land conveyed to H.M.Wood; thence south 88 degrees 10 minutes west along said south line 141.45 feet to an iron pipe; thence south 88 degrees 10 minutes west 20 feet to a point on the west line of Adams' lend, said point being 100 feet from the bank of the White Salmon River; thence following along the west line of Adams' lend and 100 feet from the bank of said White
