- (f) Lots one (1) and two (2) and the southeast quarter of the northwest quarter of section thirty (30); Lot four (4) of section nineteen (19); the southeast quarter of the northeast quarter and the east half of the east half of the southwest quarter of the northeast quarter of section six (6); the northeast quarter of the southeast quarter of section six (6); the quarter of the northwest quarter of section five (5); the southeast quarter of the northwest quarter, and the morth half of the southwest quarter of section five (5); the south half of the northeast quarter and Lot two (2), and the northeast quarter of the southeast quarter of the southeast quarter and the southeast quarter and the sest half of the southeast quarter of the southwest quarter and the west half of the southwest quarter of section five (5), all in township five (5) north of range eleven (11) east of the Willamette Meridien.
- (g) The northwest quarter of the northwest quarter of section fourteen (14), in town-ship six (6) north of range ten (10) east of Willamette Meridian; reserving certain rights by way of easement for flooding and booming already conveyed by said Lumber Company to the said Frost Improvement Company.
- (n) The north half of the southeast quarter and the southwest quarter of the northeast quarter of section nineteen (19); the northwest quarter of the southwest quarter of section twenty (20); the south half of the southeast quarter of section nineteen (19); the northeast quarter of the northeast quarter of section thirty (30); the southwest quarter of the southwest quarter of section twenty (20); Lots three (3) and four (4) and the east half of the southwest quarter of section nineteen (19), all in township six (6) north of range ten (10) east of Willamette Meridian.
- (i) The east half of the east half of section twenty-one (21); the southeast quarter of the southwest quarter and the west half of the southwest quarter of section twenty (20); the northwest quarter of the northwest quarter of section twenty-nine (29), all in township six (6) north of range eleven (11) east of Willamette Meridian.
- (j) A strip of land one hundred (100) feet wide on east side of the White Salmon River in the northwest quarter of the northwest quarter of section twenty-three (23), and the west half of the southwest quarter of section fourteen (14), all in township three (3) north of range ten (10) east of the Willamette Meridian, which parcel of land is not included in said trust deed or mortgage.

All rights under that certain contract of sale covering the northeast quarter of the southwest quarter and the south half of the southwest quarter of section 24 in township 5 north of range 10 east of the Willamette Meridian, State of Washington, executed by Northern Pacific Railway Company in favor of C.E.Moulton, which contract is entitled L.C. No.8890, Contract No.769\$, List Vancouver No.285, and bears date December 14, 1909, assigned by C.E. Moulton to Ctis J. Smith, and by said Smith and Ida L. Smith his wife, assigned to the ELECTRIC COMPANY.

All the rights of Morthwestern Electric Company as assignee of Mortimer Fleishhacker in a certain contract of sale with Ham, Yearsley & Ryrie, a corporation, dated the 19th day of April, 1911, whereby said Ham, Yearsley & Ryrie agreed to sell to said Fleishhacker, and said Fleishhacker agreed to buy, certain lands and riparian water rights on the Klickitat River, State of Washington, described as follows:

(a) All the riparian rights in the waters of the Klickitat River in the State of Washington where the same runs between the south line of thenorth half of the northwest quarter of section thirty-five (35), township three (3) north of range-north-of range twelve (12) east of Willamette Meridian, and the line running between sections seventeen
